Giacomo Mandarinò | *Chairman, Portfolio Manager*

Before joining the General Partner as a manager, Giacomo worked in the actuarial department of RAS (now Allianz Group) since 1979 and until 1984, when he joined Fideuram Vita (now part of the Intesa Sanpaolo Group) where he was responsible for the training of the sales network of financial consultants.
